## Neighborhood Watch Meeting Recap

Last May, Lieutenant John Patterson and Patrol Officer Adria Warren met with residents of Wexford Village Homes Association at the Alicia Ashman Public Library to explain the Madison Police districts and to offer tips on neighborhood safety.

Safety tips from the meeting:

- Display house numbers clearly so first responders can find your house.
- Keep garage doors and windows closed (even during the day) to prevent theft.
- Lock cars that are left out (during the day and overnight), and do not store garage door openers in these vehicles.
- Trim trees and bushes away from windows so burglars can't hide.
- · Install motion-detection lights.
- Use timers for various interior lights.

- Put a hold on mail and newspapers when going out of town, and have someone take care of your snow removal/lawn maintenance.
- Make a list of all valuables in case you need to file a police and insurance report.
- Use window stops on 1st floor windows.
- Leave a spare key with a neighbor instead of under the doormat
- Place a sturdy piece of wood in sliding door tracks or use a foot-activated lock to make them difficult to open.
- Call police if you see strange activity.

Reminder that the City of Madison reguires homeowners to remove snow and ice from sidewalks by noon of the day after the snow has stopped. If ice is difficult to remove, sand or salt should be applied. Fire hydrants in front of properties should also be cleared, and mailbox should be easily accessible for postal carriers.

### Wexford Park

A new storage shed is in Wexford Park. The dimensions 9x13, and it is located next in their homes, and we no longer need to to the current shed. It sits on rot resistant chemically-treated landscaping timber skids, which are on a bed of crushed limestone for ventilation and water drainage underneath. The current shed is on a concrete slab. The option to use limestone saved a significant amount of money in building costs and time. The new shed does not have electricity.

This new space eliminates the need for

board members to store park equipment track who has what equipment.

Wexford Village Homes Association paid \$2000 for the shed. The City of Madison Parks Department paid for the rest and did the installation. This spring, the Parks Department will stain the new shed.

The park is open in the winter. Thanks go to Ken Schmidt and Greg Delwiche for maintaining the ice-skating rinks.

# **Leasing Your Property**

There are a number of homeowners in the Wexford Village Homes Association that lease their property to family members or other individuals. Recently, there have been a few situations where the tenants were not taking care of the property or were a nuisance to other residents. The Wexford Village Homes Association is not responsible for the actions of renting tenants and has no authority to restrict who rents in our association. Homeowners must be diligent in researching prospective renters. There are agencies in Madison

that can help homeowners find renters and also manage the property.

Even if a homeowner is not residing at the property, they are still responsible for making sure the association dues are paid and that the property is maintained to the standards listed in our covenants.

If residents have issues with renters, the board suggests contacting the homeowner to discuss the situation. If necessary, residents can also contact the City of Madison police department.

# **Sidewalk Repair for District 19**

In 2014, the City of Madison will repair defective sidewalks in our district. You might have noticed sidewalk markings this fall. Sidewalks marked with a white "X" and arrows or dashes are to be replaced. Sidewalks marked with a pink line and a white "C" are to be cut to remove a tripping hazard.

Property owners with sidewalk needing to be replaced will be mailed an estimate in

early spring. Owners can hire a licensed contractor and pay 100% of the repair costs or have the work done by the City contract and pay 50% of the repair costs.
