a. Review of Middleton Street Lawsuit- Greg Siebold 4' Fence, notice sent. Refused to take down, suit filed. As trial date approached (May 2006), they agreed to settle by either removing fence or construct an in-ground pool based on plans approved by the board. Trial removed from calendar. Wrote up settlement, plaintiffs were un-respondent. They didn't agree to the settlement. Instead they dug a hole 6'x3' and bought a rubber pool, filled with water and took out a permit with the city for a pool. Issues: Do they have a pool? Is the fence issue enforceable? Battle was if covenants were enforceable. Other fences brought up. City inspector called it a pool. They can keep the fence as long as they have a pool. However, the fence does not completely enclose the 'pool'. To force judge's order, it is recommended we file a complaint with the city that they have a pool that is not in compliance. Going forward, the deed restriction is enforceable. Motion: Have Greg write a letter to the city on pool violation. Motion seconded and passed.
