Meeting came to order at 1905

- 1) The minutes for the August 3_{rd} meeting were reviewed an approved for posting on the Wexford website.
- 2) Financial report by Paul Stang- The financial report was reviewed and approved. Only a few residents have not paid the dues for 2010. Presently, we have over \$5500 in checking and \$47,000 in money market. We remain significantly below budget for the year, However, we have a few more months of mowing, \$4000 for repaving of a bike path, and potential repairs on lights.

3) Announcements

TDS with White Construction have been installing a fiber-optic network within Wexford. There has been significant digging and trenching within private yards and Wexford greenways. Any concerns of incomplete restoration or damage will be reported to TDS.

4) Old Business

Bartelt Paving has resurfaced most of the paths that were under warranty from the 2008 project. One area near Westfield Road was interrupted and not completed due to the TDS construction

The reconstruction, grading, and paving of the path adjacent to Applehill and East Newhaven is scheduled to be completed soon. Don will get the exact date from Bartelt Paving.

The park bench in Lot 400 (Wexford Prairie) that was damaged by a construction vehicle has been replaced.

A few neighbors have expressed a concern about the residential status of a house on Sawmill Road. Contact with City and County representatives have not yielded any answers.

5) New Business

A motion was made and approved to replace three light poles in the area of Applehill and East Newhaven with one centralized light. Estimated cost is \$1200-\$1500 depending upon the location of the underground wiring.
